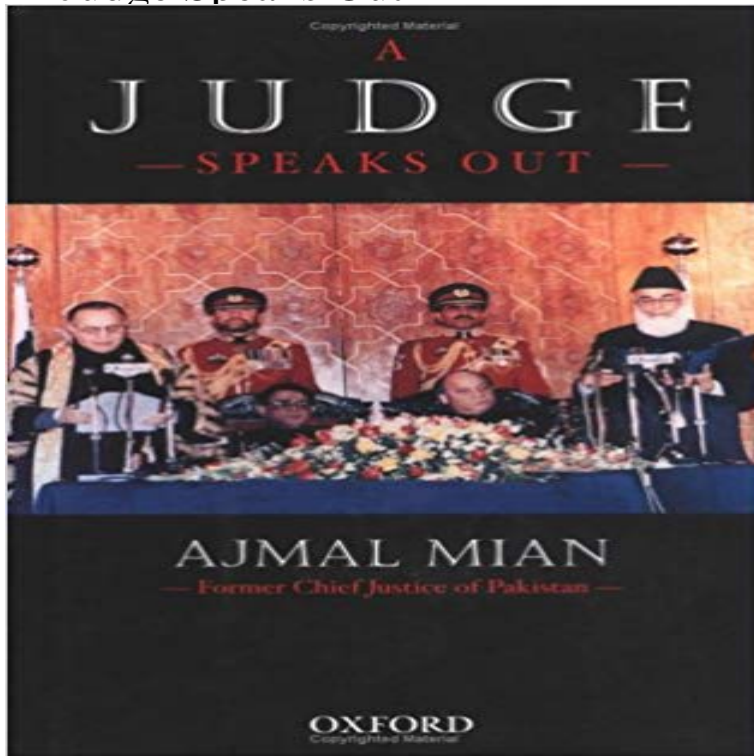


A Judge Speaks Out
