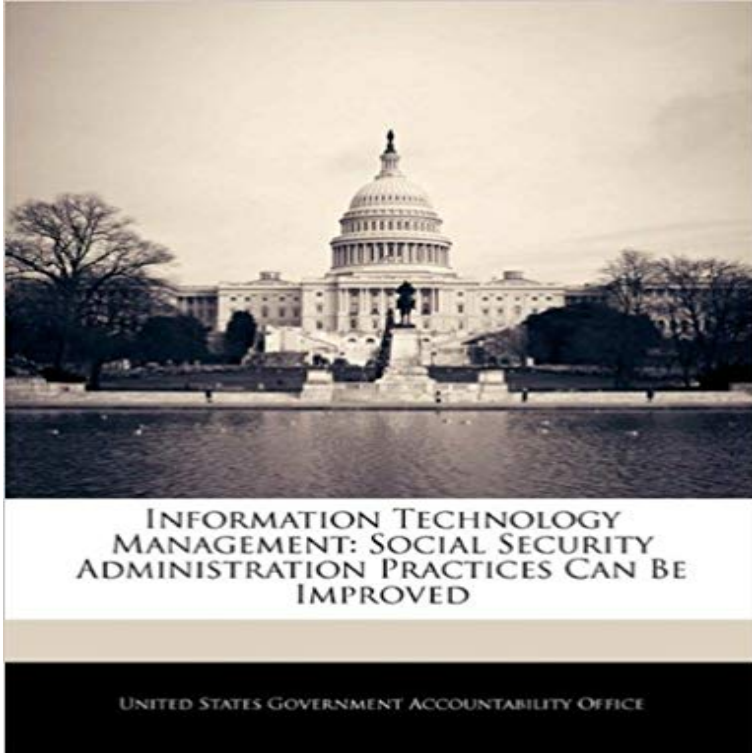


# Information Technology Management: Social Security Administration Practices Can Be Improved
