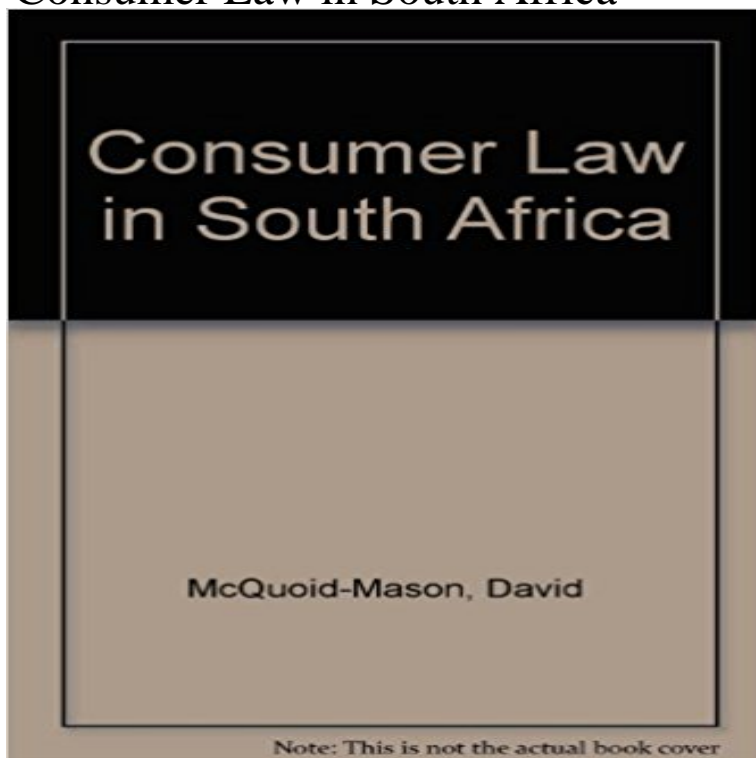


## Consumer Law in South Africa
