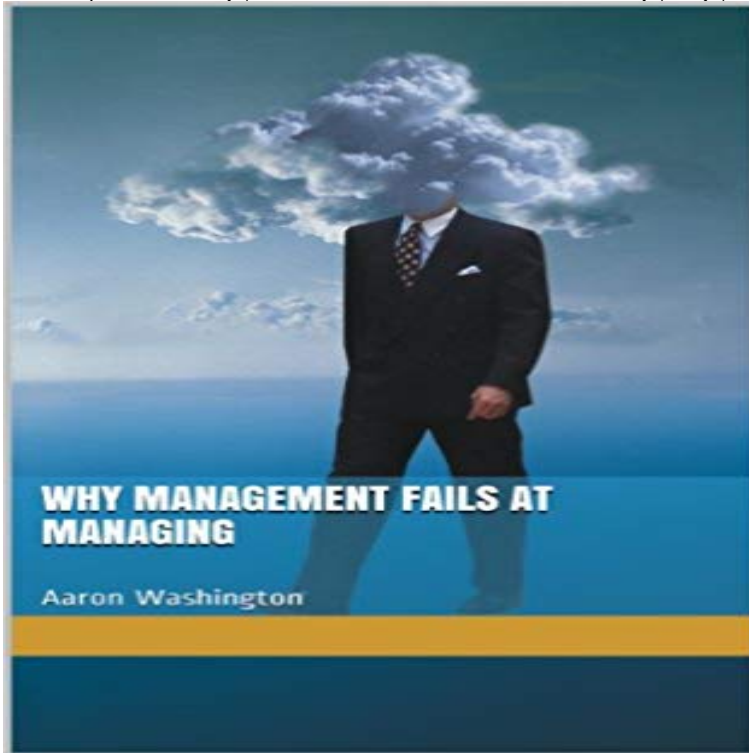


## Why Management Fails at Managing
