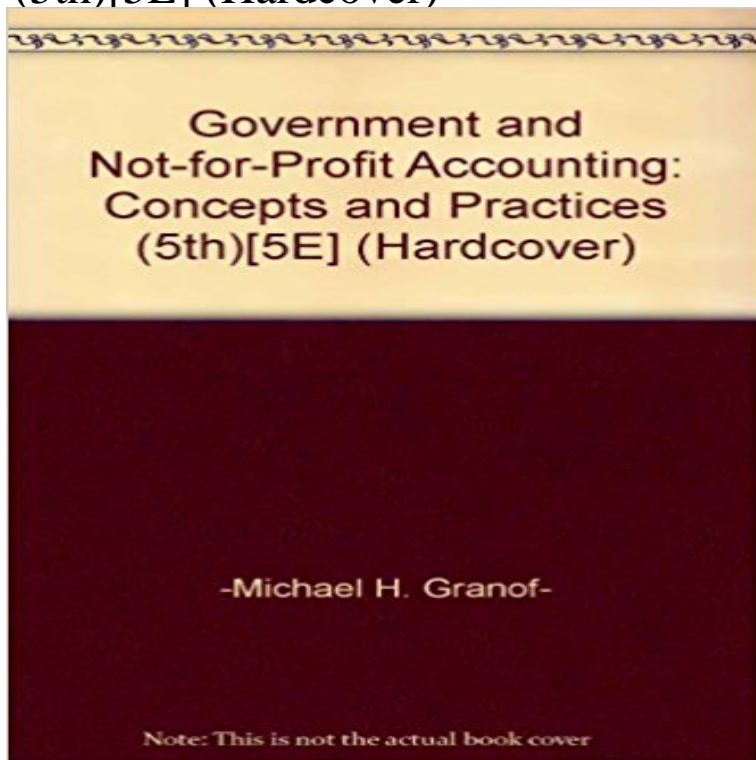


## Government and Not-for-Profit Accounting: Concepts and Practices (5th)[5E] (Hardcover)
