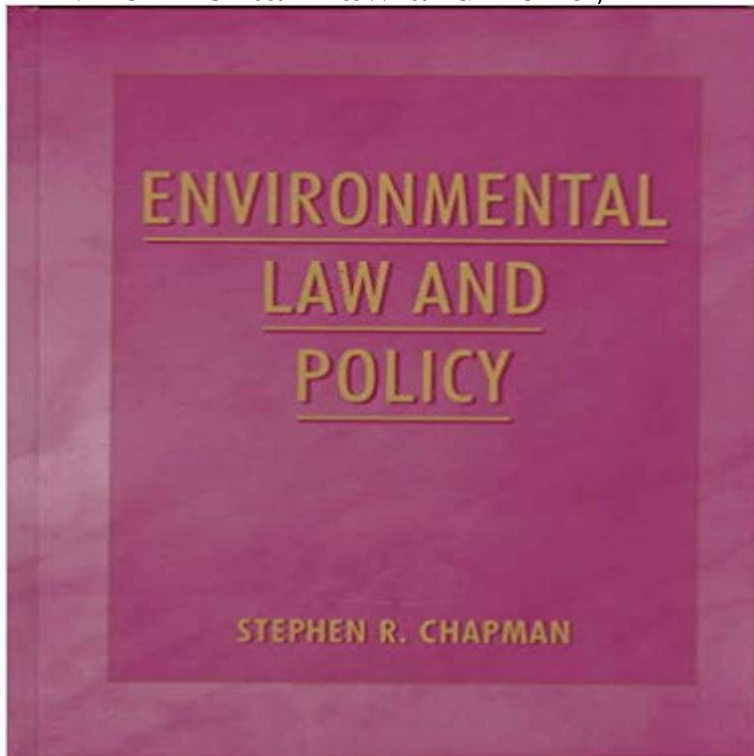


Environmental Law and Policy
